# **Bauer Highlands Parking**

*Where are homeowners supposed to park???* There are streets in our neighborhood where many

homeowners park their cars on both sides of the street, making it difficult for moving vehicles to proceed through these streets. Homeowners need to be reminded that Article 4.9 in the CC&Rs, state that "Garages shall be **PRIMARILY** used for vehicular parking and not solely for storage". The Board encourages all homeowners to park at least one vehicle in the garage and any additional vehicles in their own driveway, clearing up the streets to

allow drivers to safely pass through. Street parking

The Board of Directors is constantly making efforts to maintain standards for the beautification of our neighborhood. A common problem we are currently witnessing is the location of trash and recycling bins for certain homes. Our CC&Rs indicate that garbage and other waste shall be kept in appropriate containers for timely and proper disposal, out of public view. No trash and storage containers shall be visible from any adjacent street or neighboring Lot. The Board is fully aware that there is limited space in our lots as well as our garages to place these bins. We just ask that each homeowner "hide" their trash and recycling cans from public view whether they are placed behind shrubs or a fence avoiding any open areas clearly visible from the street. Thank you for helping us maintain these standards!

Article 4.10 states that "No Owner shall permit any vehicle which is not currently licensed, inoperable, or is in an extreme state of disrepair to be abandoned or to remain parked upon any Lot for a period in excess of 48 hours". The Board will be revisiting this hot topic and making an assessment on whether or not we should implement No Street Parking rules on certain streets where it is particularly difficult for moving vehicles to pass through when both sides of the street have parked vehicles.
